1 INVITATION FOR PRE-QUALIFICATION.

1.1 Introduction

Established over a century ago, we have expanded our reach with headquarters in Nairobi and branches in Naivasha, Nanyuki, Watamu and Mombasa.

The organization solely relies on fundraising efforts and donations to fulfil our mission.

KSPCA invites applications for pre-qualification form interested vendors, including current suppliers for the provision of goods, services, works and consultancy to the organization for the period January 1,2026 to December 31, 2027.

Prequalification is open to eligible companies, individuals and voluntarily formed joint ventures as indicated in the instructions to companies.

1.2 Sustainable procurement at KSPCA.

KSPCA has been intentional about incorporating sustainable procurement practices in its initiatives. To this end, we encourage suppliers to consider adopting best practices in the delivery of both goods and services.

KSPCA views sustainable procurement as prioritizing the procurement of products and services that have the lowest environmental and ethical impact and the most positive social results, while still achieving the best overall value. It is about embedding relevant sustainability considerations into processes for selecting services and goods, alongside traditional considerations like price, quality, service and technical specifications. In practice, this means considering sustainability in every stage of purchasing services or products.

2 PRE-QUALIFICATION INSTRUCTIONS.

2.1 Introduction

KSPCA invites interested and eligible candidates who meet the set criteria to apply for prequalification. Current suppliers **must** also reapply if they wish to continue working with KSPCA.

2.2 Objective

To establish a list of qualified and reliable suppliers who may be invited to provide goods, works or services under framework agreements or request-for-quotation processes during the specified period.

2.3 Experience

Prospective suppliers must demonstrate successful delivery of similar goods or services to reputable organizations (Government, NGOs, or Corporations). Evidence of experience and commitment to meet KSPCA standards is required.

2.4 Submission Requirements

Applicants must complete and submit all required forms and documentation. Incomplete submissions or failure to meet mandatory requirements will lead to disqualification.

2.5 Submission Deadline

Prequalification documents must reach the KSPCA offices no later than Friday 13th February 2026, at 12:00 noon.

2.6 Additional Information

KSPCA reserves the right to ask for additional information or clarification from applicants.

2.7 Request for Quotations or Framework Agreements

Only successfully prequalified suppliers will be invited to participate in subsequent competitive procurement processes.

3 CONTRACT REGULATIONS

3.1 Contract Price

Contracts shall be based on unit pricing. Quantities may vary depending on demand. Prices quoted must remain valid for 90 days.

3.2 Payments

Payments will be made within 30 days of delivery or completion, subject to satisfactory performance and receipt of valid invoices.

3.3 Confidentiality

Information related to evaluation and qualification processes shall remain confidential. Any attempt to influence the process may result in automatic disqualification.

3.4 Notification

Only successful applicants will be notified in writing.

3.5 Right to Accept or Reject

KSPCA reserves the right to accept or reject any application and to annul the process without incurring any liability or obligation to inform affected applicants.

4 ESSENTIAL CRITERIA FOR PRE-QUALIFICATION

4.1 Invitation to prequalification

Companies/Businesses registered under the Laws of the Land in respective services/consultancies are invited to submit their tender documents to KSPCA so that they may be pre-qualified for submission of tenders/quotations. All mandatory information must be provided by any eligible and interested firm.

4.2 Past experience

Prospective companies must have carried out successful supply and delivery of similar items/services to institutions of similar size and complexity. Potential companies must demonstrate the willingness and commitment to meet the tender criteria.

4.3 Eligible companies/consultants

The procuring entity strongly encourages submissions from people living with disabilities, women, and marginalized groups to promote inclusivity and diversity in the procurement process.

4.4 Safeguarding, corruption and terrorism

Eligible and interested companies acknowledge that:

- KSPCA has a zero-tolerance attitude towards acts or omissions, whether actual or alleged, that could be construed as sexual harassment or bullying, or the failure to prevent sexual harassment or bullying, by or of the Tenderer's Personnel, KSPCA staff members or consultants, or beneficiaries whom the services are intended to benefit.
- Given, offered, accepted or agreed to give, offer, or accept any gift or consideration or other advantage of any kind as an inducement or reward for: (i) doing or forbearing to do or for having done or forborne to do any act in relation to the obtaining or execution of any tender (including, without limitation, this tender), the grant of any right or license or the exercise of any function or activity; and/or (ii) showing favour or forbearing to show favour or disfavor of any nature to any person or entity in relation to any tender,

contract, right, license or to the exercise of any function or activity, where to do so would amount to a bribe or inducement under Kenyan law.

- Have not provided support of any kind in violation of applicable law to a person or entity that the tender knows or has reason to know advocates terrorism or engages in terrorist activity.

4.5 Pre-qualification fee

Interested individuals/companies shall not be required to pay any fees for the prequalification.

Application must include a sworn statement by the tender applicant ensuring the accuracy of the information given.
